May 2008 Monthly Project Status Report

Enclosed you will find our Monthly Project Status Report, for the period ending May 9th. Notable activities include the following:

Construction:

- The ballpark pile driving is complete! Helical piles remain to be installed for the loading dock area, and in the area of the mat-slab beneath the 5th Street bridge.
- Pedestrian bridge columns and piercaps are ongoing near the 2nd/6th intersection.
- All precast beams are fabricated for the pedestrian plaza and bridges.
- Column placement adjacent to the BNSF tracks is complete, and girders have been placed over the BNSF mainline to Gridline 8. This work will continue adjacent to, and over the tracks from south to north over the next two months.
- The core building slab and foundation is complete, and portions of the crash wall are in place. Underground electrical ducts to the Northstar and Hiawatha commuter platforms are currently being installed.
- Service level column placement is now proceeding from 7th Street north along the third base line. Grade beams and foundations for the stadia raker beams are underway, and have been completed around home plate.
- The main concourse deck from right field towards home plate is complete, and now has turned north along the BNSF ROW. Shoring and forming and placement of the club level decks continue along 7th Street, and the first suite level deck has been poured.
- Collisys Electric has begun installation of new light fixtures for the I-394 lighting system beneath the "A" and "B" ramps.
- Northstar has mobilized and resumed work on the 5th Street bridge deck, and the landing area adjacent to the ESB building. A new pedestrian sidewalk design has been issued by Northstar to connect the ESB to the ballpark sidewalk.
- Utility work is scheduled to begin in 3rd Avenue North in June, when Xcel Energy and Qwest will begin installation of ductbanks to provide power and fiber/communications to the ballpark.
- In July Centerpoint Energy will begin installation of the final leg of the natural gas main serving the ballpark, down 3rd Avenue North from North 2nd Street, across Washington, to the MTC turnaround. This work should be completed in late August.
- Hennepin County is preparing to begin installation of a new steam supply and condensate return line beneath the 7th Street bridge, from the HERC to the NRG steam facility at 7rh/Glenwood. Coordination with the ballpark project is ongoing.
- Mortenson has awarded the contract scope for installation of the stormwater detention/retention tank in the south parking lot. It is Mortenson's desire to complete this scope, along with paving for approximately half of the south lot, in this construction season so as to provide unimpeded access to the facility through the next winter season.

 Mortenson is imminently prepared to begin subgrade preparation for the new Northstar storage track, which will be situated between 7th Street and Royalston Ave, alongside the Cedar Lake Bike Trail.

Design:

- SRF Consulting continues to develop the 2nd Ave. signal conversion plans.
- A conceptual plan is being circulated for review to enhance the pedestrian sidewalk approach to the ballpark along 3rd Ave North, from 12th to 7th St.
- Final design of the chiller pad and access road is underway, and will be complete shortly.

Budget:

Schedule:

• Overall the project remains on schedule.

Community Participation (thru April):

Quality:

- AET and Braun-Intertec continue to provide on-site special inspections and testing. Discrepancies and non-conformance items are recorded and tracked until resolved.
- MnDOT personnel have completed their inspections for the pedestrian bridge structures over I-394.
- HOK continues to provide on-site observation reports.

Claims/Change Orders/Disputes:

- Waste Management has formally responded to Dakota County that ballpark soils stockpiled within
 the floodplain of the Minnesota River will be removed and used as Alternate Daily Cover within the
 lined landfill. That material is currently in the process of being moved.
- A claim for compensation was received from Met Council, for "acceleration" of the Lametti tunnelrelining project, so as not to impact the ballpark schedule. That claim is currently being reviewed by staff and general counsel.
- Changes of various magnitudes are regularly reviewed and addressed, which primarily are reflective of changes that arise in the design and contracting of a fast-track project.

Below is a status update on the components of our Community Participation Program.

SWMBE Program

- The SWMBE project goal is 30%. The aggregate SWMBE participation achieved to date is 31%.
- We have procured approximately \$204M dollars of work for the project with \$64M committed to SWMBE firms.
- Approximately 40 SWMBE firms are involved with the project with numerous firms having multiple contracts including 9 firms with prime contracts.

Workforce Diversity

- The project utilization goals are 25% minority and 5% female. The goals are expressed as a percentage of the total project work hours.
- The project utilization levels through March were 16% minority and 6% female with approximately 209,000 total hours worked. This is an increase in the minority participation from February.
- There has been significant improvement in the performance levels of the subcontractors with the March participation levels averaging 26% minority and 7% female. This performance has contributed to the steady increase in the minority participation.
- There were approximately 300 workers on the project in March.

Community Workforce Program

- 14 individuals have been hired for the CWP program: 7 females and 7 males.
- The referral organizations have been Summit Academy, Construction Careers Coalition (CCC), Merrick and the St. Paul College.

Outreach

- We continue to have discussions and meetings with subcontractors regarding the procurement opportunities on the project.
- On May 6, we held an open house to announce bid package 7 (finishes and interiors) contracts to the contracting community. 150 businesses/individuals attended.

- Application letters were sent to high schools March 1.
- Applications were received from students from Roosevelt, Washburn, Henry, DeLaSalle, and Richfield High.
- Interviews are scheduled with students from Roosevelt, Edison and Washburn High.
